

Canada's Leader Broke Ethics Law, Says Report

Finding Comes Just Months Before Vote

OTTAWA — Canadian federal ethics commissioners found on Wednesday that Prime Minister Justin Trudeau had violated an ethics law that restricts what he can do in his private life. The report says that Mr. Trudeau had a sexual relationship with a woman before he was sworn in as prime minister.

In a 10-page report, the commissioners, whose terms end in September, said Mr. Trudeau had used his office to influence a government decision.

"The law that requires public officials to disclose their financial interests was intended to prevent the government from using its power to influence a decision in a way that would be in its own interest," the report says.
